## View from the Helm: Winter is Here

The Log calendar lists dates and titles of upcoming classes and programs. We should keep in mind that programs arranged by Cheryl Duvall and classes, now under the direction of Mike Dhillon, are available to the public (with few exceptions) as well as members. These are opportunities to show the boating community that CAPCA serves their interests beyond being a source of captains for

deliveries, charters, on-board instruction, etc. What can the Board of Directors (BOD) do to provide better service and to offer programs and instructional classes that are strong attractions to boaters?

I ask members to please contact me or any member of the BOD to share ideas for topics to cover in future programs and classes.

It's the dead of winter. The middle to end of January gave us day after day of temperatures below freezing. We may be concerned that our marina could freeze and threaten the hull of our boat in the slip. However, those who were around in years gone by may recall the winter of 1977. This *Chesapeake Bay Magazine* report offers this recollection:

It goes down as the Chesapeake Bay's biggest freeze on record. In the winter of 1977, ice over a foot thick virtually shut down the Bay—except for the pilots bringing ships in and out of port. That year, Bay pilots faced nonexistent channel markers, anchors that wouldn't break through the ice, and precarious helicopter landings on ships.


I don't live on my boat. During the cold months the boat is in its cradle. During the winter I think about making the next boating season a better experience. To improve cooperation between the person on the helm and the crew on the bow I obtained, with the recommendation of a colleague, two-way communication headsets. I anticipate less confusion when setting and securing the anchor and pulling into a slip. Hand signals, at times obscured by the mast, will no longer be necessary. Also, broadcasting a voice from bow to helm on a 42-foot boat can be difficult, particularly in windy conditions when communication is most important. I also purchased an "H2Out" unit that, when installed in the diesel fuel tank air vent, prevents water from coming in and allows water vapor to be expelled. In an effort to do more cruising with my family on our boat, I will coordinate my teaching schedule and social calendar with my wife.

In closing, please consider serving as a volunteer to staff our booth at the upcoming boat shows. We will need multiple CAPCA members to assist in these efforts. See the details below on p. 5.

# Winter Port Condition One Set as Ice Builds Up in Bay Tributaries

The Captain of the Port Sets Winter Port Condition One. The Coast Guard issued a safety broadcast Notice to Mariners on Jan. 10, 2025 announcing several locations experiencing 40% ice coverage up to two inches thick, including the C&D Canal, Welch Point to Nine Foot Knoll, and Turkey Point. Further south, Quantico to Alexandria, Virginia, and the D.C. Harbor and Anacostia River were experiencing 30% coverage of packed ice one inch thick. The Nanticoke and Wicomico rivers had 15 percent ice coverage one inch thick.



Ice breaking continues as dozens of navigational aids are destroyed and boats are trapped. Read this article in Chesapeake Bay Magazine for more details.



# Speaker Summary: Jan. 27 "Running Your Captain Business" By Captain Bob Thomson, CAPCA Secretary



With forty-six CAPCA members and guests in attendance at the Elks Lodge in Edgewater, and another fifty-two participating remotely via Zoom, we had a full-capacity audience eager to learn more about using our captains' licenses productively. This program was presented in a panel format, with accomplished maritime business professionals representing key areas of expertise.

Captain Davis Jones, the owner of Shardana Sailing Charters (and CAPCA's vice president), spoke from the perspective of starting up and running a successful charter and instruction operation. April Balech, a

Gallagher - Charter Lakes account executive with a long career in marine insurance, helped attendees understand important concepts and practices in covering business and personal risk. Chase Eshelman, an associate attorney with Lochner Law Firm, P.C., rounded out the panel with

legal aspects of business planning and operation. Captain Bob Thomson served as the moderator for the conversation.

We learned that one of the first things to think about is whether to offer our professional captain services as an individual person, or to operate within a legal entity organized for this purpose. A common entity type is the limited liability company (LLC), which is inexpensive to establish and has the important advantage of shielding its organizer (that is, you, the captain) from personal risk. For more complex business operations, including ownership of property and hiring of workers, some form of corporation may be appropriate. A good way to approach this decision is to have a conversation with a financial professional qualified to advise small businesses on getting started.

The next key business consideration is insurance. We know how important this is when a high-value asset such as our own vessel is being used. However, even when providing services on someone else's boat, such as deliveries or instruction, captains may want to have insurance for professional liability and protection of their licenses. Carefully reviewing your business plans with an experienced marine insurance professional can help you select the policy types and coverages needed to provide adequate risk protection. But your work isn't done once you have the policy in hand. We learned how important it is to thoroughly understand your policy's terms and limits and to operate in accordance with them; otherwise, your coverage can be affected and even denied.

Our legal expert on the panel reviewed some key concepts important to working captains. While captain jobs are sometimes arranged on a handshake basis, a written agreement can better protect the interests of both parties by defining responsibilities and expectations. A qualified maritime attorney can help you create documents suitable for your business. This small investment can pay off in terms of preventing disputes down the line. Anyone who hires people to perform work must comply with labor laws, but the Jones Act places additional responsibilities on captains who hire crew members. You may be responsible for lost wages and medical bills in the event of an injury to a crew member. A legal consultation can help you plan how to hire crew while limiting your risks. Another important consideration in planning a captain job is to ask the vessel owner to add you to their insurance policy for the duration of the job, affording you a significant level of protection.

We hope that our captains in attendance came away from the discussion better prepared to do what they love to do on the water. You worked hard for many years to earn your merchant mariner credential. A small investment in talking to the right professionals can go a long way toward more rewarding days underway.

# Meet the Captain: Captain Lindsey Williams



## An interview with Captain Cheryl Duvall

## What did you do before getting into boating?

# "Ahoy" from Your Membership Director

Current active membership stands at 329. Please help spread the word to all the non-member captains that you know about the professional development opportunities and benefits, including numerous discounts, that come with a CAPCA membership.

In accordance with the bylaws of the Chesapeake Area Professional Captains Association, (CAPCA) you must maintain a current Merchant Mariner Credential, (MMC) or Coast Guard Document of Continuity.

Don't put your CAPCA membership in jeopardy due to an expired license. CAPCA bylaws allow members to remain active if their license expiration is within the renewal grace period prescribed by the Coast Guard, normally one year. The Coast Guard recently announced a temporary extension of the one-year grace period to six years. Since you are in this grace period, your membership remains active; however, we don't know how long the Coast Guard will keep this temporary extension period. As stated in the Coast Guard announcement, "the administrative grace period does not extend the validity of an MMC and a mariner may not sail under the authority of an expired credential."

Once you have renewed your license, please be sure to log on to the CAPCA members page to update your license expiration date and upload a copy of your current license.

**ABYC Happenings**

What can ABYC do for Licensed Captains?

CAPCA maintains a group membership in the <u>American Boat and Yacht Council (ABYC)</u> for the benefit of our members, but apparently not too many of you have checked out the resources to see what might be useful to you.

Based in Annapolis, ABYC is a non-profit, member organization that develops voluntary global safety standards for the design, construction, maintenance, and repair of recreational boats. Some of ABYC's standards are incorporated into USCG regulations.

ABYC also has a long-established commitment to providing technical education, training, certification, and professional development. Their seminars, workshops and technician certification courses are instrumental in increasing the level of knowledge and professionalism throughout the boating industry.

If you have a boat of your own or operate vessels while working your license, ABYC information can be useful to you. Among the many topics we highlight in the CAPCA *Log's* ABYC column are articles about electrical systems and batteries, engines, winterizing, buying a European boat, crash investigations, marine law, ABYC Standards application and compliance, safety equipment, ABYC courses and seminars, joysticks, and towing vessel regulations. The ABYC website has much more for members on the "Industry Site" (top menu tab).

To access the member side of the ABYC website, log in to <a href="www.capca.net">www.capca.net</a> with your user name and password and click on MEMBERS KIT, Discounts. The second item in Discounts list is ABYC, with the login information for the ABYC website. We keep that information there for security reasons.

On the "Industry Site" tab of the ABYC website you'll find:

- The <u>standards and online Standards Library</u>, with enhanced search functionality. You also can call their Technical Department with questions and get free advice.
- Online referral directories: You can look up a business or list your business. Directories include: ABYC Members, Certified Technicians, Manufacturers, and Surveyors.



- <u>Educational videos and webinars</u> to learn more about marine electrical, marine corrosion, marine systems, diesel and gas engines and support systems, composite boat building, etc.
- <u>ABYC Certification courses</u>, most of which are discounted up to 30% for members vs. non-members. If you are a Master Marine Technician these savings add up fast!

The <u>ABYC Recreational Boaters</u> side of the website (tab in upper right) is open to the public. There you can find lists of certified technicians and marine surveyors, watch DIY videos,

see boat systems checklists, and see how ABYC standards apply to recreational vessels.

Please check out the ABYC website and see what may help you continue to operate your vessels professionally and safely. And keep reading "ABYC Happenings" in the CAPCA *Log*.

# Coast Guard Foundation Activates Emergency Disaster Relief Program August 15, 2024



The Coast Guard Foundation, a non-profit organization committed to strengthening the Coast Guard community and service by supporting members and families, announced that its emergency disaster relief program is providing vital assistance to Coast Guard members and their families impacted by Hurricanes Beryl and Helene, Tropical Storm Debby, and glacial flooding in Juneau, Alaska.

In response to these natural disasters, the Coast Guard Foundation has activated its emergency disaster relief program to provide immediate assistance to Coast Guard members who have been directly affected. 

# Uninspected Passenger Vessel Exams



CAPCA member Bruce Johnson is a USCG Licensed Master, as well as a member of the U.S. Coast Guard Auxiliary designated as a UPV examiner. Captain Johnson is available to do Uninspected Passenger Vessel exams for those who want them. Members can request UPVEs or ask questions any time by emailing him at <a href="mailto:bruce.johnson@cgauxnet.us">bruce.johnson@cgauxnet.us</a> or calling 410.707.1682 and leaving a message.

Voluntary UPV examinations are available to assure that owner / operators comply with federal regulations. If the vessel passes a UPV exam a decal is

issued. Since this is a voluntary dockside exam, it is not a law enforcement action, and no citations are issued. On the other hand, passing a UPV exam does not absolutely guarantee that the vessel may not be boarded when it is underway.


Uninspected Passenger Vessels (UPVs) are vessels not subject to Coast Guard inspection that are less than 100 gross tons with 6 or fewer passengers, including at least one passenger for hire. UPVs may also include vessels over 100 GTs but less than 300 GTs that carry not more than 12 passengers, with at least one being a passenger for hire. All UPVs must be under the direction and control of an individual credentialed by the Coast Guard. The original license or Merchant Mariner

Credential (MMC) must be aboard and available for immediate presentation to CG officials whenever passengers are being carried for hire. There are additional equipment and performance requirements for UPVs.

# CAPCA's Crew Registry Program

Captains: Looking for licensed crewmembers for a delivery job, an assignment as an instructor, or any other onthe-water venture?

**Crewmembers**: Looking for a slot as a crewmember, either for pay or to gain experience?



Either way, CAPCA's CREW REGISTRY program can help you. Here's how it works:

- If you're a CAPCA member who'd like to serve as a crewmember for another CAPCA member, fill out and submit the crew registry sign-up form on the member side of the website. Your name and the information about your interest and qualifications will appear on the Crew Registry list.
- 2. **IMPORTANT:** Note these two questions on the signup form, "Currently enrolled in a U.S. Coast Guard-recognized random drug screening program?" and "Name of drug screening program."

Your answers to these questions should **reflect** *your current status*. You DO NOT have to be enrolled in a drug screening program unless your work as a captain requires it. If you're **not** in a screening program, answer "NO" and "NONE" to the questions. If you **are currently** enrolled in a drug screening program, answer "Yes" and enter the name of the program in the box.

A captain seeking crew may need a crewmember who is currently enrolled in a drug screening program, so it's important to indicate if you are or are not in a screening program.

When you renew your license (and in some other employment situations), a drug *screening test* is required, as the Coast Guard specifies: "A drug test is required for all transactions EXCEPT documents of continuity modifications (increases of scope), duplicates, and International Endorsements (STCW)."

However, a number of captains do the drug screening test just for license renewal, and if their employment as captains does not require enrollment in a drug screening program, they do not enroll after the test.

- 3. Captains **looking for crew**, log in to the member side of the CAPCA website and examine the crew registry list to see the available crew listings. The most recent postings appear at the top of the list.
- 4. If a captain is interested, he or she can contact you directly and you two can work out arrangements for duties and pay.
- 5. The list of members who have signed up for crew duty will remain available indefinitely. The list will form a crew registry to which captains can refer time after time.
- 6. Editing your information: If any of the information you filled out on your registry form changes, or if you no longer want to be included on the Crew Registry list, you can edit or delete your listing yourself. Log in with your member username and password, click the CREW REGISTRY menu item and the blue "Edit Your Listing" button. You will see four icons to the right of your listing for viewing, editing, deleting, or downloading. You can hover your cursor over each icon to see what it does.

7. If you are on the Crew Registry, this might be a good time to **review your listing**. If any of your information has changed, you can update it with immediate results. If you are no longer interested in being listed on the Crew Registry, please delete your listing.
