



However, in the lives of boaters it's the time when we anticipate the warmth of spring and perhaps begin planning excursions and lengthy cruises. As these plans are being made, we will certainly select our ports of call, gunkholes in which we will seek shelter and good

anchoring, consider the courses we will sail, and verify the tides and anticipated currents we will encounter.

The recent appointment of RFK, Jr. as the new secretary of Health and Human Services brings his concern about the quality of our meals and the risks associated with highly processed food. The HHS secretary's policy recommendations will be based on his desire to minimize the health risks related to our overconsumption of processed food and under consumption of whole foods. The galley will be well stocked for our multiday cruise. Captain Elizabeth A. Christman grew up in central New York. She attended SUNY Maritime College and graduated in 1987 with a BS in Marine Transportation, an Unlimited Third Mates License from the U.S. Coast Guard and a Commission as an Ensign in the U.S. Naval Reserves.

She sailed on merchant vessels after graduation, working on tankers, tugboats, training ships and cruise ships. She passed her Unlimited Masters license in 1992. Soon after, she returned to SUNY Maritime College to take night classes in their Graduate Program, while she worked on the Training Ship *Empire State VI*, ultimately graduating in 1995 with an MS in Transportation.

In 1996, she was selected by the Maryland State Board of Pilots and commenced training with the Association of Maryland Pilots on the Chesapeake Bay and C&D Canal. She completed her 5 years of training in 2001 and became an Unlimited Licensed Pilot with the Association. She was elected Secretary of the Board of Supervisors by the Association membership, charged with overseeing the Association business from 2006-2016. She was on the Maryland State Board of Pilots Incident Committee from 2006-2010. On July 21, 2020, she was elected to serve on the Board of Supervisors as 1<sup>st</sup> Vice President of the Association of Maryland Pilots and served in the position until June 18, 2024. Presently, she is an active pilot with the Association of Maryland Pilots.

She participates on the American Pilot Association NavTech committee, is the Vice Chair of the U.S. Coast Guard NMEDMAC committee and is on the Charitable Trust Board of the Propeller Club of Baltimore.

Speaker Summary February 24: Matt Stegman and Johnny Shockley, "Taking Action to Protect the Chesapeake Bay"

All of us who make our living on the Chesapeake, as well as those who just take great pleasure in being on and around this extraordinary waterway, have a deep interest in efforts to sustain a clean, healthy, and welcoming bay. While population growth, development, and competition for resources have put pressure on the aquatic ecosystem, dedicated organizations and individuals are working diligently to balance these interests with a commitment to steadily improving the condition of the Chesapeake.

Our February program showed us how both very large and very small organizations can have a positive impact. Matt Stegman spoke on behalf of the Chesapeake Bay Foundation. With 190 staff members across four states and over 200,000 members, CBF works to shape legislation, policies and education beneficial to the well-being of the Chesapeake. As the CBF Staff Attorney for Maryland, Matt focused on issues and outcomes of the 2025 Session of the Maryland General Assembly, which runs from January to April.

A dominant issue for this Session is reducing a \$3 billion deficit, with \$300 million potentially coming from agencies and programs essential to protection of the Bay. The uncertainty of federal support may affect some programs. Matt also highlighted key issues in the Virginia and Pennsylvania

legislatures. He encouraged people to get involved, noting that as few as ten calls to legislators on important issues may sway their vote. On a smaller, but no less vital scale, is Blue Oyster Environmental (BOE). Founded by our cospeaker, life-long waterman Johnny Shockley, this operation seeks to restore the Chesapeake's historic oyster industry by pioneering methods of aquaculture to seed, grow, harvest, and market this important marine food source. It is estimated that through the late 1800's oysters were abundant enough to filter the Chesapeake every three days and provide about one-half of the world's demand.

A century later, overfishing, pollution and disease reduced the oyster harvest to about one percent of historic levels. Johnny and his team have developed equipment and techniques that offer the promise of restoring this once-thriving sector of life on the Bay. The Hoopers Island Oyster Company, a division of BOE, can harvest 17,000 oysters each day. Among BOE's other innovations are EcoDocks installations, offering waterfront property owners a means to grow their own local oyster habitats. In addition to boosting the shell-fishing economy, a restored oyster population can help mitigate nitrogen and phosphorus levels and also control the over-proliferation of phytoplankton, another pollution contributor. Everyone in our maritime region can benefit from a cleaner, healthier Chesapeake Bay. Hopefully this presentation will encourage you to become more informed and find meaningful ways to make a difference.

# Meet the Captain: Joanne Keazer



# An interview with Captain Cheryl Duvall, Program Director

Where did you grow up? I was born in Kittery, Maine, so from a very early age I loved being on the water. My dad worked for U.S. Customs and Border Patrol, which back then was part of the U.S. Treasury department. By the time I was 15 years old, I had lived in several different places including Texas multiple locations, Louisiana, and Florida. We moved to Naples. FL when I was a sophomore in high school, and I can't imagine a more energizing place to spend my teenage years. It was loads of fun on the water in the hot sun.

**Did you play sports in high school and college?** I was a serious swimmer. And I mean serious. I swam before AND after school during high school. There were lots of early mornings! After

graduating high school, I attended college in Grand Rapids. MI for two years to focus on my swimming and receive an associate's degree. Then I finished my bachelor's degree in Criminal Justice at Florida International University in Miami so that I could apply for my dream job.

**Your dream job? What was that?** From an early age, I wanted to work for the Secret Service. Actually, it was my dad who inspired me. He was a boat captain for U.S. Customs Service in the 80s, and his job was catching drug dealers on the water. He regaled my two younger sisters and me with exhilarating stories where no two days were the same. He talked about the eclectic lives of Secret Service agents, because they must be physically fit and able to do a variety of sports to keep up with those they protect. Even as a young girl, I loved being active, and I thought a job that included horseback riding, scuba diving, hiking, and long runs, would be an exciting life.

**Isn't it difficult to be accepted into the Secret Service?** Oh yes! And my dad was concerned that I'd get my heart set on it and then be disappointed. So when I was 11 years old, I wrote a letter to the Secret Service and asked lots of questions. And I got a reply! I continued to pursue the studies and skillsets I needed and was accepted. I enjoyed a long fulfilling career in the Secret Service, spanning twenty-five years. I retired in 2020 from my position as Deputy Assistant Director so that I could spend more time with my son and daughter who were entering their middle and high school years. I knew they'd be off to college soon, and I wanted to spend more time with them before time slipped away.

**Did you acquire your boating experience as part of the Secret Service?** Actually, an early part of my boating experience occurred in Miami during my college years. I began racing sailboats and couldn't get enough! I sailed J24s, J30s, and 40-foot Js as well. Later, I sailed small performance catamarans. But yes, eventually I expanded my boating skills with the Secret Service through their rescue swimmer and boat training programs. Because they were adding vessels to the Secret Service fleets, they needed to train captains and crew. One of the merchant marine schools came

to Fairfax, where I lived, and I was able to complete their program in 2005. Combined with the sea time from years of sailing, I was able to get my 50-ton captain's license that same year.

Do you work your captain's license now? Yes! I now live half-time in Severna Park with my husband Steve and half-time in Fairfax. I absolutely love Annapolis! I decided that I wanted to "work something at the Annapolis City Dock." So last year, I joined Watermark, working initially as crew on their big boats before being minted captain of the Miss Anne, their 22passenger Crosby tugboat that does tours from the harbor and along Spa Creek. I'm really enjoying working for Watermark and look forward to expanding my captain positions on their other boats.



**Do you still swim?** I currently swim with Maryland Masters out of Severna Park Community Center. I have competed in the 4.1-mile Chesapeake Bay Swim and the 2.1-mile Freedom Swim in the Choptank. If I am not on the water, I will be in it!

**How did you find out about CAPCA, and when did you join?** Several captains at Watermark are members of CAPCA and encouraged me to consider membership. I joined in October 2024 and was able to attend the December General Meeting in-person. I'm looking forward to meeting more members at CAPCA events, including Women of CAPCA happy hours.

# "Ahoy" from Your Membership Director

Current active membership stands at 333. Please help spread the word to all the non-member captains that you know about the professional development opportunities and benefits, including numerous discounts, that come with a CAPCA membership.

In accordance with the Bylaws of the Chesapeake Area Professional Captains Association, (CAPCA) you must maintain a current Merchant Mariner Credential, (MMC) or Coast Guard Document of Continuity.

**Don't put your CAPCA membership in jeopardy due to an expired license.** CAPCA Bylaws allow members to remain active if their license expiration is within the renewal grace period prescribed by the Coast Guard, normally one year. The Coast Guard recently announced a

temporary extension of the one-year grace period to six years. Since you are in this grace period, your membership remains active; however, **we don't know how long the Coast Guard will keep this temporary extension period.** As stated in the Coast Guard announcement, "the administrative grace period does not extend the validity of an MMC and a mariner may not sail under the authority of an expired credential."

Once you have renewed your license, please be sure to log on to the CAPCA members page to update your license expiration date and upload a copy of your current license.

# **ABYC** Happenings

# ABYC - Revised Gasoline Fuel Systems Standard

The American Boat & Yacht Council (ABYC) published the H-24 Gasoline (Petrol) Fuel Systems standard, introducing new requirements for in-tank fuel pumps and their associated fuel hoses.

The U.S. Coast Guard (USCG) has issued a policy accepting the H-24 standard's requirements for in-tank fuel pumps as equivalent to federal regulations found in 33 CFR 183.566. This policy permits builders to use in-tank fuel pumps located beyond 12 inches from the engine without

obtaining an exemption from the USCG. The policy does not require any additional compliance labeling on the boat.

"Our new policy allowing fuel pumps to be placed in fuel tanks in compliance with ABYC H-24 (2025) provides flexibility to boat manufacturers to incorporate the latest fuel system technology," said Jeff Ludwig, chief of the USCG Office of Auxiliary & Boating Safety's Recreational Boating Product Assurance Branch. "The policy would not have been possible without the extensive testing conducted by ABYC and the hard work of the Fuel & Ventilation Systems Project Technical Committee."

"This standard paves the way for manufacturers to safely solve the challenges associated with supplying gasoline in high-



horsepower applications without getting exemptions from the USCG," said Brain Goodwin, ABYC



standards and compliance director. "This is a significant step forward for the industry, supporting both efficiency and the highest safety standards."

Advantages of pump-in-tank installations include increased pump life due to a continuous, laminar supply of fuel to the pump and an environment that facilitates lubrication and heat dissipation.

H-24 published in January 2025 is now available in the ABYC online library. The standard includes a recommended compliance date of Aug. 1, 2027, allowing manufacturers time to integrate the changes into their production processes.

# **Owner Gets Prison Term in Fatal Capsizing of Passenger Vessel**

USCG Press release Jan 31, 2025.

NEW YORK — The owner of the vessel *Stimulus Money*, Richard Cruz, was sentenced to 18 months in prison January 25 after pleading guilty for his role in the July 2022 capsizing of the vessel while underway on the Hudson River that resulted in the death of two passengers, a seven-year-old boy and 48-year-old woman.

Cruz was arrested in March 2024 along with the operator of the vessel, Jaime Pinilla Gomez, and charged with one count of misconduct and neglect of a ship officer resulting in death, which carries a maximum sentence of ten years in prison.

Coast Guard Sector New York and the Coast Guard Investigative Service investigated the incident into suspected illegal passenger operations, finding the vessel did not possess the required Certificate of



Inspection and the operator did not have the required Coast Guard-issued merchant mariner credential to operate a passenger vessel. The Coast Guard referred the case to the U.S. Attorney's

Office for the Southern District of New York for further consideration in potential criminal prosecution.

The Coast Guard urges the public to be on the lookout for illegal charters to ensure their safety and the safety of others. If a vessel is carrying six or more passengers, with at least one paying for the charter, it must have a valid <u>Coast Guard Certificate of Inspection</u>. Passengers can and should ask the captain of the vessel to verify their license and the inspection status of the boat. All passengers should check the boat's maximum capacity plate, if equipped. There should not be more passengers or weight on the boat than it is equipped for.

Not only do illegal charter operations potentially constitute a violation of federal law, but owners and operators of vessels may also be subject to civil penalties of \$60,000 or more for illegal passengerfor-hire operations. Charters that violate a Coast Guard Captain of the Port Order may also be subject to civil penalties of \$117,608 per violation.

Some potential civil penalties for illegally operating a passenger vessel are:

- Up to \$9,624 for failure of operators to be enrolled in a chemical- testing program.
- Up to \$5,996 for failure to provide a Coast Guard Certificate of Inspection for vessels carrying more than six passengers for hire.
- Up to \$20,468 for failure to produce a valid Certificate of Documentation for vessels over 5 gross tons.
- Up to \$14,988 for failure to have been issued a valid Stability Letter prior to placing a vessel in service with more than six passengers for hire.

Mariners suspecting a passenger vessel is operating illegally should immediately contact Coast Guard Sector New York by using VHF-FM channel 16, call (844) NYC-USCG, or contact CGIS TIPS at <u>https://www.p3tips.com/878</u>.

## Coast Guard Foundation Activates Emergency Disaster Relief Program August 15, 2024



- 4. Open the downloads folder on your PC or tablet. Find the file that begins with your CAPCA username, open and print. The membership card will be wallet-size when cut out.



# Website Spotlight: Navigation Resources




The web team works to make your website a timely resource that's both informative and useful. It's kept up to date and new material is added to keep the site current. This column will help you get familiar with some of the website's features.

USCG New Online "Launch and Recovery" Charting App Provided by Hans J. Hoffmann, former CAPCA Vice-President

Captains, indeed, all mariners planning a DELMARVA circumnavigation or cruises to points south, will soon have an additional charting tool available. This charting app will provide space launch and re-entry information off the east coast, including Wallops Island, Virginia. This is how the U.S. Coast Guard has recently announced the new app:



COMING SOON: NAVCEN will be releasing our new Space Operations Launch and Recovery (SOLAR) geospatial visualization tool in the near future. The initial build of this tool will be available in the Coast Guard Seventh District with further expansion in 2024.

SOLAR will offer a practical solution for mariners and the shipping industry to access real-time, geospatial information about space launches and reentries. This information is critical for navigating safely in areas affected by space operations. The tool will be available online at www.navcen.uscg.gov, providing an accessible platform for users to stay informed.

Key features of the tool include:

1. Interactive Display: A visual format for easier understanding of restricted navigation areas.

2. Updated Information: Timely data on space launches and reentries to help mariners make informed decisions.

3. Online Accessibility: The tool is readily accessible on the NAVCEN website.

This tool will align with NAVCEN's goals to modernize maritime communications and provide relevant, upto-date information to mariners and other stakeholders.



# The CAPCA Mentoring Program Is Now Self-Service



# Uninspected Passenger Vessel Exams



CAPCA member Bruce Johnson is a USCG Licensed Master, as well as a member of the U.S. Coast Guard Auxiliary designated as a UPV examiner. Captain Johnson is available to do Uninspected Passenger Vessel exams for those who want them. Members can request UPVEs or ask questions any time by emailing him at <u>bruce.johnson@cgauxnet.us</u> or calling 410.707.1682 and leaving a message.

Voluntary UPV examinations are available to assure that owner / operators comply with federal regulations. If the vessel passes a UPV exam a decal is


issued. Since this is a voluntary dockside exam, it is not a law enforcement action, and no citations are issued. On the other hand, passing a UPV exam does not absolutely guarantee that the vessel may not be boarded when it is underway.

Uninspected Passenger Vessels (UPVs) are vessels not subject to Coast Guard inspection that are less than 100 gross tons with 6 or fewer passengers, including at least one passenger for hire. UPVs may also include vessels over 100 GTs but less than 300 GTs that carry not more than 12 passengers, with at least one being a passenger for hire. All UPVs must be under the direction and control of an individual credentialed by the Coast Guard. The original license or Merchant Mariner Credential (MMC) must be aboard and available for immediate presentation to CG officials whenever passengers are being carried for hire. There are additional equipment and performance requirements for UPVs.


# Worldwide Port Information

# CAPCA's Crew Registry Program

**Captains**: Looking for licensed crewmembers for a delivery job, an assignment as an instructor, or any other onthe-water venture?

**Crewmembers**: Looking for a slot as a crewmember, either for pay or to gain experience?



Either way, CAPCA's CREW REGISTRY program can help you. Here's how it works:

- 1. If you're a CAPCA member who'd like to **serve as a crewmember** for another CAPCA member, fill out and submit the crew registry sign-up form on the member side of the website. Your name and the information about your interest and qualifications will appear on the Crew Registry list.
- 2. **IMPORTANT: Note these two questions** on the signup form, "Currently enrolled in a U.S. Coast Guard-recognized random drug screening program?" and "Name of drug screening program."

Your answers to these questions should **reflect** *your current status*. You DO NOT have to be enrolled in a drug screening program unless your work as a captain requires it. If you're **not** in a screening program, answer "NO" and "NONE" to the questions. If you **are currently** enrolled in a drug screening program, answer "Yes" and enter the name of the program in the box.

A captain seeking crew may need a crewmember who is currently enrolled in a drug screening program, so it's important to indicate if you are or are not in a screening program.

When you renew your license (and in some other employment situations), a drug *screening test* is required, as the Coast Guard specifies: "<u>A drug test is required</u> for all transactions

EXCEPT documents of continuity modifications (increases of scope), duplicates, and International Endorsements (STCW)."

However, a number of captains do the drug screening test just for license renewal, and if their employment as captains does not require enrollment in a drug screening program, they do not enroll after the test.

- 3. Captains **looking for crew**, log in to the member side of the CAPCA website and examine the crew registry list to see the available crew listings. The most recent postings appear at the top of the list.
- 4. If a captain is interested, he or she can contact you directly and you two can work out arrangements for duties and pay.
- 5. The list of members who have signed up for crew duty will remain available indefinitely. The list will form a crew registry to which captains can refer time after time.
- 6. Editing your information: If any of the information you filled out on your registry form changes, or if you no longer want to be included on the Crew Registry list, you can edit or delete your listing yourself. Log in with your member username and password, click the CREW REGISTRY menu item and the blue "Edit Your Listing" button. You will see four icons to the right of your listing for viewing, editing, deleting, or downloading. You can hover your cursor over each icon to see what it does.
- 7. If you are on the Crew Registry, this might be a good time to **review your listing**. If any of your information has changed, you can update it with immediate results. If you are no longer interested in being listed on the Crew Registry, please delete your listing.




